Congratulations on joining your local paralegal association! As a member of your local association you are also a member of the National Federation of Paralegal Associations, Inc. (“NFPA®”). We invite you to take advantage of the many opportunities and benefits which come along with your membership in NFPA. NFPA is the Leader of the Paralegal Profession®. As such, NFPA continues to represent paralegals nationally by researching and analyzing issues that affect the paralegal profession; monitoring legislative actions and proposed court changes; and working closely with other national legal associations, including the American Bar Association (ABA), the American Association for Paralegal Education (AAfPE) and the International Paralegal Management Association (IPMA). NFPA has invested significant resources to assist you in becoming a credentialed paralegal. NFPA has offered the Paralegal Advanced Competency Exam (PACE®) to test the competency of experienced paralegals for more than a decade. NFPA also offers a credentialing examination geared toward entry-level and early-career paralegals - the Paralegal CORE Competency (PCC™) exam.

Your membership in NFPA is an invitation to network with other paralegals, to stay abreast of proceedings affecting our profession, and to become involved in advancing the paralegal profession. As a member of your local association and NFPA, you have the opportunity to serve in leadership positions such as a board member, coordinator or member of a committee, thereby providing you first-hand opportunities to foster, promote and develop the profession.

NFPA holds annual conferences that members may attend at a reduced rate.
