### **Thursday, November 16, 2023, at 12:00 p.m. – A Review of the New Vermont Uniform Power of Attorney Act with Mark Langan, Esq. (60 minutes)**

Mark A. Langan is a tax attorney at Dinse P.C. in Burlington. He has practiced law since 1981 in New Hampshire and Vermont. Mr. Langan is the current chair of the Probate and Trust Section of the Vermont Bar Association, a fellow in the American College of Trust and Estate Counsel (ACTEC), and editor of A Practical Guide to Estate Planning in Vermont. Mr. Langan was chair of the committee that reviewed and drafted the Vermont Uniform Power of Attorney Act which became effective July 1, 2023.

Vermont passed the Uniform Power of Attorney Act in 2023 and it became effective July 1, 2023. This will be a general overview of the statute and what you need to know when using and reviewing powers of attorney forms.
