Probate Law Updates

During the 2018 Legislative session, S. 29 was officially passed by both the Vermont House and Vermont Senate with changes becoming effective July 1, 2018.

There were a lot of changes to probate law, some minor, others more substantive. Please refer to <u>https://legislature.vermont.gov/assets/Documents/2018/Docs/ACTS/ACT195/ACT195%20As%20Enact-ed.pdf</u> if you practice in this area for more detailed explanations.

Here are some of the changes:

- The addition of Self-Proving Wills.
- Further clarity for the elective share and the written waiver of spousal rights by the surviving spouse.
- The claim period when not filing the notice to creditors decreased to one (1) year.
- The time for filing an inventory increased to 60 days.
- There is also an option for interested parties to affirm to the court that they are satisfied with the administration of the estate and waive the final accounting by the fiduciary, upon satisfaction of certain conditions.
- There is now an option for a waiver of administration.

Down to the nitty-gritty. NFPA's 2018 Annual Convention is right around the corner. They will represent your voice on a national level, and as we have done in the past, we will provide you with the proposed Agenda Topics for the Convention and ask that you provide your thoughtful opinions, so that we can make decisions based on the direction which the VPO membership would like to see the paralegal profession take. NFPA, like the VPO, is a membership-driven organizational body, so your thoughts can be what direct the future of the organizations and profession. This year we will be posting the Agenda Topics to the Members Only Forum on our website, so log in and let us know your thoughts. We are anxiously awaiting the posting of the agenda topics on the NFPA discussion boards. We have heard that there are at least 14 possible topics with the potential for more to be introduced at convention as "late" topics. It will certainly be an interesting policy meeting with this many proposed topics!

With another NFPA Convention on the horizon that also means another election for our NFPA Board of Directors. Candidates for the Board of Directors must be voting members in good standing in their voting member association.

NFPA is still awaiting nominations for the Education Coordinator position, which is an elected 3-year non-Board position term. The Education Coordinator will be Co-Chair of the Education Committee with the ABA Approval Commission Representative and should have the following qualifications:

- 1. Possess a four-year degree from an accredited college or university;
- 2. Possess a background in paralegal education, i.e. teaching experience within a paralegal program or service on an advisory board for a paralegal program;
- 3. Demonstrate articulate, professional, assertive and imaginative skills and abilities;
- 4. Be well-versed in NFPA history and policy;
- 5. Make the commitment to support NFPA's ABA Approval Commission Representative; and
- 6. Possess the ability to travel to conventions, conferences and other activities required by and affecting the duties and responsibilities of Education Coordinator.

Corinne and I continue to attend the monthly telephonic NFPA Board Meetings. The most recent of which were July 13 and August 21, 2018. A few items of interest are:

- NFPA has developed a review schedule for its Code of Ethics, the first revisions of which will be submitted to Delegates at the 2019 Annual Convention.
- The NFPA Board is updating its Policies and Procedures to change the monthly meeting agenda availability for the membership to 7 days prior to the meeting as opposed to the original 30 days prior to the meeting, which was unrealistic with the monthly Board Meeting schedule.
- NFPA has sent a letter to the American Bar Association requesting that they remove the term "legal assistant" from their definition of paralegal. This was done with the hopes of reducing the confusion of legal secretarial work with substantive legal work that is completed by paralegals.
- NFPA is looking into better technological opportunities to more effectively communicate with its membership, as there have been a couple of monthly board meetings that were hampered due to attendees' inability to hear what was being discussed. NFPA is also looking to find an alternative for the Discussion Boards to increase communication among the membership.
- The PACE® and PCCE® exam fees and study manual fees will be increasing effective January 2019 and January 2020, respectively. For members, the PACE test will increase to \$325 and the PCCE® test will increase to \$275. The study manuals will cost \$125 plus \$15 shipping and handling.
- NFPA is going to be working with Affinity to revamp and revive its discounts program, so keep an eye out for that.
- NFPA is considering eliminating the grace period for payment of dues prior to initiating penalties and interest for unpaid dues.
- NFPA is updating and revising their "NFPA: What It's All About" document on the website.
- NFPA is working on updating and streamlining the procedures regarding Awards and Scholarships.

Besides the NFPA Annual Convention in Seattle, we can also look forward to the 2019 Joint Conference being held in Denver, Colorado. The Joint Conference will take place April 26-28th at the Hampton Inn & Homewood Suites in Downtown Denver. The Rocky Mountain Paralegal Association was able to lock in room rates at \$169/night including a free hot buffet breakfast. While the VPO has been unable to attend Joint Conference in the last couple of years, it is a wonderful conference that highlights Leadership, Regulation and Paralegal Certification. Like many paralegal gatherings, attendees get formal education and informational seminars, but Joint Conference also offers the chance to share professional ideas and network with paralegals from across the country.

Last, but not least, don't forget to check out weekly updates on your News You Can Use from NFPA, and, of course, we will be providing a comprehensive rundown on Convention in our next newsletter.

A Brief Introduction

Currently, I work for The State of Vermont Agency of Transportation. I draft and develop legal documents related to the State's acquisition and/or sales of real property.

I also work for a community outreach and transitional care program in Addison County. The program assists families struggling with poverty, drug addiction, homelessness and other barriers preventing family stability.

I am passionately dedicated to the mission represented by this Committee. It is my hope that we will effectively and collaboratively establish a strong community of Paralegals and Attorneys working together to facilitate increased access to the Judiciary, particularly by those who are unable to afford proper representation. Together, we will make a difference in the lives of others.

Pro Bono Committee

We have some very exciting opportunities for VPO members to assist in the lives of Vermonters throughout the State while gaining valuable experience working with the Legal Services Law Line of Vermont.

The Law Line operates a 1800 help line offering limited legal advice and direction for Vermonters with questions and legal concerns. The call center is staffed throughout the week at the main office in Burlington. This office is currently fielding a large call volume. Paralegals who are interested in answering calls, returning calls, and performing research related to a variety of legal matters should contact me to express interest. We are evaluating the level of VPO member interest before we set a firm schedule.

Additionally, the Law Line coordinates, staffs, trains, and recruits volunteers to provide legal assistance to defendants on rent escrow day in a total of four counties in Vermont. Volunteer lawyers are matched with pro se litigants who need assistance, under a limited appearance (for the day only). Paralegals who are interested in serving as a pro bono/volunteer clinic coordinator should contact me to express interest. There are available opportunities in Rutland, Burlington, Middlebury, and Montpelier. The clinic coordinator would assist in matching the client with an available attorney, and performing brief, same day intakes.

Why I volunteer for the VPO

I am not sure how clearly I can put into words why I volunteer for the VPO; it comes from deep inside. The roles that I have taken on over the years (member since 1998) were the result of a passionate desire to help build a network for legal support staff so that we could always find someone who "had our back." I have met a lot of people over the years, and not just within our own organization, and have always felt the love and support of those in the same profession. If I had never joined the VPO when I was a student member, I would not have made as many connections as I did, which allowed me to gain confidence and grow in the profession I came to love. I was fortunate to work with some strong paralegals at Dinse, Knapp & McAndrew while I was a file clerk and attending Paralegal Studies classes at Champlain College. I started to attend VPO events, and upon getting my degree and becoming a voting member, I was encouraged to get more involved with the VPO. I soon took on the role as Membership Chair, and had that position for about six years. During that period, I worked hard to retain existing members and recruit new members. That position allowed me the opportunity to come into contact with paralegals from across the state, and to develop a support network of my own.

I also took on roles as the Employment Opportunities Chair (formerly Job Bank), assisted with the newsletter, and then later was voted in as President, and also became the Newsletter Editor. For over 10 years, I have worked with Carie Tarte to plan and coordinate CLE events, including the annual meeting which transitioned from a dinner social event to a day of mini-seminars in 2008. As challenging as it is to plan the annual meetings, I remain passionate about identifying potential topics, and then potential presenters, to give legal support staff from across the state the best possible educational opportunity at an affordable price. In addition to providing CLE opportunities, the annual meeting allows me to stay in contact with paralegals from other counties, including those who may work in other areas of the law. For example, early on in my role as Membership Chair, I coordinated a presentation on the VPO with fellow member Penny Hannigan before then Woodbury College students on a Saturday. We answered a lot of questions, and I formed a friendship with Penny that has lasted more than a decade. Penny and I don't work in the same legal field, but Penny is always ready to help out with any event in the Montpelier area, and was a panel member some years ago with other VPO members and their attorneys at a VBA event discussing the best way to work with a paralegal. It is these bonds that keep me motivated and passionate about the VPO.

As a member of the VPO, I have built up a support system over the years that include paralegals from other firms who I can contact when I encounter something new and need some help digging in, or making contact with the appropriate vendor. I consider this benefit of being a VPO member one of the most valuable. Not only does it help me in my work life, but getting together for the occasional lunch or after work is good for sanity and the soul. Laughter, which always lowers my stress level, is a guarantee with my legal buddies, and a must have.

I also believe that we can learn a great deal from each other. If someone is starting out in this profession with little experience on legal procedure, for example, being able to easily connect with someone else who has several years of experience can prove to be invaluable. I have been working as a paralegal for over 18 years, and I still seek out the assistance of my colleagues from other firms when I encounter something new. 
Website / Wild Apricot Tips By Corinne Deering, RP®


If you have already subscribed to the Forum but missed the option to change your notifications setting, this is what you can do to change your settings:


