### NFPA News

Since my last report, Summer has turned into Fall and Fall into Winter. Similarly, there have been changes on the national level relating to the NFPA which are outlined in this report.

Speaking of changes, I am happy to report that I will remain as the Primary Delegate for the VPO. Although I was honored and thrilled to have been nominated for the Director of Membership position on the NFPA Board, the nominations and election process that followed my acceptance of the nomination was rather disappointing and unprofessional. For that experience I am grateful, but for now I feel that my passion for the paralegal profession and my time promoting the profession will be better spent continuing to work with the VPO Board and members.

Robyn and I, as the VPO delegates, attended the NFPA Convention held October 7-10 via a virtual platform. There were 39 of the 44 NFPA associations represented at convention. I was pleased to see so many members of the VPO attending the seminars and region meeting. With the new virtual format and/or hybrid options, it is much easier for VPO members to be engaged on a national level and that is very exciting. The following actions were taken by the NFPA delegation at Convention:

**Agenda Topic #1** relating to the creation of an Ad Hoc Committee for Future Convention Planning. Discussion about the need for the committee was undertaken and facts presented to support the need for the committee since there is not enough representation from each Region in planning future conventions. The Convention Planning committee is busy working on current convention without enough volunteers so the ad hoc committee would relieve the convention planning committee of some of tasks. A vote was taken, and Agenda Topic #1 was passed (Resolution 2021-01).

**Bylaw Amendment** relating to Sections 5.4 and 16.2 of Policies and Procedures Manual. The discussion on this topic was tabled.

**Discussion Topic** relating to a Dues Increase. Discussion between the NFPA and the delegates involved a constructive debate of the pros and cons of a dues increase, as well as a presentation on why the increase is needed. No action was taken on this discussion topic, but the majority agreed that a dues increase would benefit NFPA while at the same time create a hardship for some associations.

**<u>2021 Certification</u>** NFPA is pleased to announce that there were 23 new RPs and 55 new CRPs in 2021.

**2021 President's Challenge** Four NFPA Associations were recognized for their contributions to the President's Challenge as follows:

NCAPA – 16 new members and 1 webinar speaker

OPA – 3 new RPs, 2 new CRPs, 26 new members and 2 webinar speakers

PAW – 2 new RPs and 62 new members

RMPA – 66 new members

**2021 Convention Elections** The following were elected to serve on the NFPA Board for a two-year term:

Director of Profession Development: Theda M. Yandell (WSPA)

Following convention, there was a NFPA Board Meeting held on November 16, with the following notable actions taken:

- The Director of Paralegal Certification (DPC) made a motion to create a new Certification Audit Coordinator position, which was approved unanimously by the Board. This position was created to help streamline the CLE requirements of certification renewals.
- Upon motion made, the NFPA Board unanimously approved the appointment of Robyn Sweet as the Certification Audit Coordinator. Robyn is the VPO's NFPA Secondary and the VPO Board congratulates Robyn on this appointment. The VPO is an association located within Region V.
- Upon motion made, the NFPA Board unanimously approved the reappoint of Jessica Mieles as Certification Ambassador. Jessica is a member of the NYCPA, which association is located with Region V.
- The Director of Marketing discussed the need to rebrand NFPA and to have an updated logo to go with the rebranding. Upon motion made to use funds from the Marketing Budget for a logo/rebranding contest, the NFPA Board unanimously approved the request.
- Upon motion made, the NFPA Board unanimously re-appointed Vanessa Laro and Brittany Curtis as the Regulation Co-Coordinators. Vanessa is a member of the CCPA, which association is located within Region V.

As a sidenote, the VPO is located within Region V. You might have noticed from the above appointments that Region V association members afford the NFPA with lots of talented volunteers. If you are interested in getting involved on a national level, please contact me to discuss the opportunities available to the VPO members.

6. NFPA Joint Conference (Leadership, Regulation and Certification) is scheduled for May 19-21, 2021 in Minnesota.

- 7. NFPA 2022 Convention will be in Cleveland - September 15-18.
- 8. National Paralegal Reporter - As many of you know, the Reporter will only be available in digital format. The Director of Marketing is looking for Articles for the next edition of the Reporter. Please contact Aaron at marketingdir@paralegals.org if you have any ideas or would like to contribute an article.
- 9. Director of Positions and Issues noted that there is a pending request in Oregon regarding Paralegal Regulation/Licensure and input from the NFPA was requested and will be provided.
- 10. Region V - Cathy Allard, Director for Region V, presented concerns raised by the delegates within Region V to the NFPA Board as to the direction of NFPA. The concerns presented included that the Delegates feel DE&I is important and recognizing the diversity of NFPA members is vital to the culture of NFPA. However, it appears that DE&I has been the primary focus of members of the NFPA Board. The Region V Delegates strongly believe that NFPA needs to focus on its core purpose of promoting the paralegal profession and leadership in the legal community. NFPA has a strategic plan in place and the Board needs to spend time on that plan. The concern is that there has been little to no mention of NFPA supporting our mission.

The NFPA Board responded to the concerns as follows: (1) Director of Marketing thanked Region V for their feedback and thinks that it is a great idea to include some legal aspects in the notice; however, he feels that informing the members of these events is important. (2) Director of Positions and Issues stated that she felt that our request may be difficult to navigate. She would like to consult the BIPOC (Black Indigenous and People of Color) and the DE&I Committee to obtain their thoughts. They will definitely take our comments into consideration. (3) There were no other comments from the Board.

If any further action or discussion is undertaken by NFPA in connection with this request by Region V, I will share that with the VPO Board and membership.

# Lau's Corner & Title Tips

#### Property Descriptions: What/What Not to Include:

Andy and Liz have been suggesting that people shorten their property descriptions because: (a) the longer the description, the greater the chance for typographical error; (b) the more reference clauses there are, the greater the chance to omit what might be important (in context) quotation marks and/or the greater the chance to resurrect old ROFR that were otherwise extinguished or have lapsed. Sometimes less is more.


#### Parameters:

- A legal description needs to comply with Title Standard 10.1.
- A legal description which simply provides: "All and the same that land and premises that Grantor acquired from \_\_\_\_\_ by deed \_\_\_\_\_" can be sufficient to pass marketable title if the referenced deed (or a deed in the chain of title) contains a Title Standard compliant description.
- Reciting/reproducing a full metes and bounds description is NOT necessary if the deed description refers to a lot on a recorded plat, e.g. "Being all of Lot 3 on a survey recorded at Map Slide 34." Typing a full metes and bounds description is not only redundant but, invariably, lengthy reproduction results in typographical errors which result in confusion/title problems.
- Encumbrances and appurtenant easements be carried forward in the new deed, e.g. "The property is subject to: \_\_\_\_. The property is benefited by: \_\_\_
- While referencing the entire chain of title is certainly helpful to future searchers, re-typing the chain 5. often results in scrivener error.
- Shortening descriptions is not a mandate it is merely a recommendation to reduce the number of problems that arise from very long deeds which, when re-typed, contain errors.

Vermont Judiciary has extended the Judicial Emergency to March 1, 2022.

Patricia Gabel will retire in late December from her role as Vermont Judiciary State Court Administrator, a position she has held for eight years. Her interim replacement is Scott Griffith, who has worked for the Vermont Judiciary as Chief of Planning and Court Services since 2019.

# **Promulgated Rule Amendments**

AO 49 Amendment - Declaration of Judicial Emergency and Changes to Court Procedures 10-14-21

This Order was promulgated on October 14, 2021, effective immediately.

Paragraph ¶ 2 is amended to extend the effective date of AO 49 until January 1, 2022, to allow for continued flexibility in court operations to respond to the course of the COVID-19 pandemic.

Paragraph 22 is amended to add pleading provisions regarding foreclosure proceedings affecting one-to-four-unit residential properties filed between August 31, and December 31, 2021. These provisions are required to satisfy amendments of Regulation X promulgated by the Federal Consumer Financial Protection Bureau (CFPB) requiring foreclosure plaintiffs in these cases to attest to compliance with CFPB requirements prior to filing for foreclosure. The CFPB amendments were designed to assist mortgage borrowers affected by the COVID-19 emergency. The final regulation establishes temporary procedural safeguards to help ensure that borrowers have a meaningful opportunity to be reviewed for loss mitigation before the servicer can make the first notice or filing required for foreclosure on certain mortgages. 12 C.F.R. § 1024.41 (eff. Aug. 31, 2021).

There is a new form, Appendix C, which tracks the language of the amended rule and has boxes to check specifically indicating compliance with, or exemption from, the requirements. Because of the need for uniformity, the required certification must be in the form reflected in Appendix C.

AO 49 Amendment - Declaration of Judicial Emergency and Changes to Court Procedures 11-15-21

This Order was promulgated on **November 15, 2021, effective immediately.** 

Paragraph 21 regarding pleading requirements in eviction proceedings is amended in several ways. Under existing ¶ 21(a), a plaintiff in a proceeding to evict a tenant in residential housing must file a certification that the filing complies with the federal CARES Act. Amended ¶ 21(b) provides that any complaint filed after December 1, 2021, is subject to dismissal if the certification is not provided. In addition, new ¶21(d) provides that any action for eviction of a residential tenant based on nonpayment of rent filed after December 1, 2021, must include a notice concerning the availability of Vermont Emergency Rental Assistance Program (VERAP) funds. The notice must be in the form provided in Appendix D. If the notice is not provided and not corrected within 30 days, the court may dismiss the case and the tenant may request to reschedule the rent escrow hearing. Finally, when there is sufficient evidence that the tenant has applied for VERAP funds, the court has discretion to take appropriate action in fashioning a rent escrow order or a writ of possession.

# **Proposed Rule Amendments**

Proposed Amendment to V.R.C.P. 50(b)

The proposed amendment to V.R.C.P. 50(b) is in response to the Vermont Supreme Court's request in Blondin v. Milton Town School District, 2021 VT 2, ¶ 26 n. 10, that the Civil Rules Committee consider whether that rule "should be amended to be consistent with the federal rule and potentially to allow consideration of pure questions of law on appeal absent renewal following judgment."

V.R.C.P. 50(b) as originally adopted in 1971 was identical to F.R.C.P. 50(b) as it then stood. In 1988 the Vermont Rule was amended to add a renewal requirement. The Reporter's Notes indicated that this renewal requirement was implicit in Federal Rule 50(b). The U.S. Supreme Court in Unitherm Food Systems, Inc. v. Swift-Eckrich, Inc., 546 U.S. 394, 407 (2006), held that failure to renew a pre-verdict motion for judgment as a matter of law under Rule 50(b) prevented appellate review of a sufficiency of evidence challenge. The proposed amendment of V.R.C.P. 50(b) adopts an interpretation of <u>Unitherm</u> advanced by several U.S. Courts of Appeals by limiting the requirement to renew the motion to sufficiency-of-the-evidence questions. The effect of the amendment is to allow case-by-case development of the line between sufficiency-of-the-evidence questions and pure questions of law.

Proposed Order Amending Rule 18(d)(2) of the Vermont Rules for Family Proceedings

The proposed amendment to Rule 18(d)(2) clarifies that mediation can take place either in person or using remote technology.

A.O. 49 was initially issued March 16, 2020, in response to the state of emergency resulting from the pandemic. Paragraph 13 of A.O. 49 authorized remote participation in mediation by video or telephone without a stipulation or court order. Further, in anticipation that at some point A.O. 49 would no longer be necessary, the Supreme Court requested that the Advisory Committee on Rules for Family Proceedings consider whether there should be a permanent change to Rule 18 related to remote participation. After considering responses from attorneys who practice family law to a Vermont Bar Association survey and responses from family mediators, the Committee concluded that both in person and remote participation in mediation should be permissible in family proceedings subject to V.R.F.P. 18 at the discretion of the mediator.
